- ⇒ Each participant must complete a registration form even if someone is paying for multiple participants with one check/money order.
- ⇒ EQIT Students must attend the entire training, including EQIT Orientation; no partial credit will be given.
- ⇒ EQIT student agrees to a minimum of 3 hours of EQIT Relate Coaching. EQIT instructor will reach out to student and arrange the drop off of classroom materials and set up coaching hours.
